IN THE MATTER OF AWARDING THE BID FOR ADDITIONS AND RENOVATIONS TO THE FRANKLIN COUNTY PUBLIC SAFETY FACILITY ADDITIONS AND RENOVATIONS - GENERAL WORKS

WHEREAS, a public notice to bidders asking for sealed bids for "General Works" for the additions and renovations to the Franklin County Public Safety Facility was published in the Washington Missourian in the March 30, 2019 edition to submit bids to the Franklin County Purchasing Department by May 9, 2019 at 9:00 AM; and

WHEREAS, four bids were received and opened and read May 9, 2019; and

WHEREAS, the following companies were deemed non-responsive per the direction of the County Counselor: KCI Construction Co., Inc., ICS Construction Services, LTD., and Wright Construction Services; and

WHEREAS, after due deliberation and consideration by Navigate Building Solutions, FGM, SCI Engineering and the Franklin County Counselor, the Purchasing Department recommends the Franklin County Commission award the bid to River City Construction, L.L.C., 6640 American Setter Drive, Ashland, Missouri 65010 for the bid amount of Eleven Million, Six Hundred and Sixty-One Thousand, Five Hundred and Twenty-Nine Dollars (\$11,661,529.00) and, in addition, to approve and authorize the following alternates:

Alternate No. 1 - Furnish and installation of 12 Ga Plank Security Ceilings \$106,420.00

Alternate No. 2 - Furnish Mezzanine Walkways, Mezzanine Stairs & Stair Railings at the Dayrooms \$110,000.00

Alternate No. 3 - Install Mezzanine Walkways, Mezzanine Stairs & Stair Railings at the Dayrooms \$143,000.00

Alternate No. 4 - Furnish and install Security Woven Rod/Barrier Screen at Dayroom Mezzanines \$183,109.00; and

WHEREAS, the Agreement will be available to view upon request.

IT IS THEREFORE ORDERED that the bid for General Works for the additions and revocations to the Franklin County Public Safety Facility is hereby awarded to River City Construction, L.L.C. for the bid amount of Eleven Million, Six Hundred and Sixty-One Thousand, Five Hundred and Twenty-Nine Dollars (\$11,661,529.00) and the following alternates are hereby approved and authorized:

Alternate No. 1 - Furnish and installation of 12 Ga Plank Security Ceilings \$106,420.00;

Alternate No. 2 - Furnish Mezzanine Walkways, Mezzanine Stairs & Stair Railings at the Dayrooms \$110,000.00; Alternate No. 3 - Install Mezzanine Walkways, Mezzanine Stairs & Stair Railings at the Dayrooms \$143,000.00; Alternate No. 4 - Furnish and install Security Woven Rod/Barrier Screen at Dayroom Mezzanines \$183,109.00 and the Presiding Commissioner is authorized to execute any and all necessary documents on behalf of the County of Franklin and such other documents, certificates
