**Addendum 01

IFB 23-B0008
Lake Arrowhead/AVX Deep Water Well Abandonment**

The purpose of this Addendum 01 to IFB 23-B0008 for Lake Arrowhead/AVX Deep Water Well Abandonment, dated August, 2022, is to list the key points of discussion from the mandatory pre-bid meeting.

- There is a possibility that the City will not be keeping the motors, as previously stated. Bidders will be advised of this potential change either prior to or at the bid opening. All other well parts can be considered as scrap.
- Contractor will be responsible for all DHEC permits and paperwork.
- Tremie method must be used.
- The wells are located inside a pump house, and can be pulled out via the skylight in each building.
- Wells are approximately six hundred (600) feet deep, with a diameter of approximately six to eight inches.
- Contractor will have full access to each pump house. The City will provide lock access. There is a water supply on site.
- The Contractor is expected to maintain site cleanliness at all times.
- Additional site visits can be scheduled by calling George Conroy at 843-918-2099.
- The City will be responsible to remove items from the work area such as power lines, trailers, picnic tables, etc.
- Contractor will be responsible for the path needed to get their equipment to the work site. Any damage to grounds, fencing, etc. will be the Contractor's responsibility to repair.
- Additional questions are due no later than close of business on Tuesday, September 6, 2022. Questions may be submitted via e-mail to asowers@cityofmyrtlebeach.com. All questions received by the deadline will be answered via addendum no later than Tuesday, September 13, 2022.
- Sealed bids are due in the Purchasing Office no later than 2:00PM (local time) on Tuesday, September 20, 2022. No electronic submissions will be accepted. The City of Myrtle Beach is not responsible for late or misdirected mail.
- The mandatory pre-bid sign-in sheet is attached and is hereby made part of this addendum.
