Q2 Are there any utility hookups currently on the property, i.e., water, electricity, or gas?

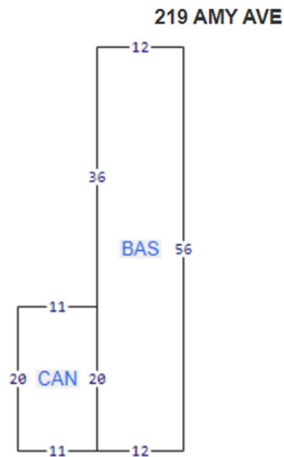
A2 This would be the contractor's requirement to have the services disconnected.
