This Addendum forms part of the Request for Proposal (RFP) Package advertised on January 5th, 2023, and with a bid opening date of February 1st, 2023 February 23rd, 2023, with any amendments and/or additions noted below.

Minutes for Mandatory Pre-Bid Hearing on January 17th, 2023

The meeting started at 10:03 am with the Procurement Specialist introducing herself and Eric Machado, IT Manager. The procurement specialist stated that Mr. Eric Machado would be the person in charge for the services advertised and therefore, any technical questions should be addressed to him. The procurement specialist went over the key dates for the solicitation. The procurement specialist asked if there were any questions as to the deliverables or preparation of the proposal. Key points were discussed as to the following:

- Extension of Bid Opening Date from 02/01/2023 to Thursday, February 23rd, 2023, at 3:00pm same location.
- A new extension to submit questions was extended to **Thursday**, **February 9th**, **2023** at 3:00pm. Last addendum will be issued if there are questions that need to be answered.
- As to the scope section of **e. Support**: The following will clarify some of the questions that arose during the meeting.
 - 1. The proposal will have (2) components, one proposal shall be the price of the equipment, installation, all permits required and be a "turn-key" project.

This agreement will be for three (3) years with an option to renew at the Village's request and agreed upon by the vendor for an additional (2) years. This service encompasses camera replacement, handle warranty issues, trouble shooting camera for any issues that render the camera not operational.

- 2. When a service call is initiated, the vendor has 24-36 hours to respond to any issues arising from the operations of the cameras. At that point they need to respond to the IT Department and give them a diagnosis of the issue and set a time to remedy the situation.
- As to licensing, the Village requires a minimum of 3 years.
- A walkthrough "fieldtrip" will be done to examine all the locations included in the scope. The set date and time will be as follows:
