1. **Reference Section III, Specifications:** The section is amended as follows:

~~The successful bidder must provide all of the following sections as one bid to be awarded as one contract. Bidders are not required to bid on all sections of the project.~~

All prices shall be firm and fixed for the specified contract period. Unit prices shall be inclusive of all costs including equipment, power tools, materials, labor, overhead, profit, insurance, rental equipment, freight, travel, fuel, delivery, set-up charges, taxes, etc. for a turn-key installation. The District shall not honor any hidden costs, which may be invoiced at a later date relating to items in this solicitation. If the District chooses to install, price of materials will be negotiated with contractor.

2. **Reference Section VI. Award Criteria:** The section is amended as follows:

AWARD BY ITEM OR LOT: Award will be made by individual items and/or complete lot(s).

AWARD CRITERIA-BIDS: Award will be made to the lowest responsive and responsible bidder.

~~**AWARD TO ONE OFFEROR:** Award will be made to one offeror.~~

AWARD TO MULTIPLE OFFERORS: Award may be made to more than one Offeror.

1. **Question:** Can sections of the RFP be bid on. For example, can the bid just be for the audio system and the projection system? Not the theatrical intercom or the curtain system.
