**Question 2:** If the quote is accepted and it gets a renewal for the 4 years will there be an adjustment on pricing at that time or do we need to quote with a price that will be good for 4 years?

**Answer:** 29. PRICE ESCALATION/DE-ESCALATION:

**Prices are to remain firm for the first contract period. In subsequent terms, the contractor may request, in writing at least sixty (60) days in advance of the contract ending date, and increase/decrease. Should the County elect to exercise the option to renew the contract for additional year(s), the contract prices for the additional years shall not exceed the percentage increase/decrease of the “Services” category of the CPI-W SECTION OF THE COMSUMER PRICE INDEX of the United States Bureau of Labor Statistics for the latest twelve month for which statistics are available. Should the price change be granted and the County elects to renew the contract, the purchase order will reflect the changes.**

**Question 3:** When do you anticipate the start time for this job? Early 2023 or December 2022?

**Answer:** We will not need material until early 2023.
