



## RFP – GPS Fleet Tracking

### Addendum #1 – February 18, 2020

We have received a variety of questions related to the GPS Fleet Tracking RFP. We have attempted to provide answers to those questions below. We thank you for your interest in doing business with Jones County.

1. So that we can provide the County with the best economy of scale, can you please provide the quantity of vehicles to which you expect to implement this solution?
  - a. **Please see the attached list. Please note that the County does not guarantee that the devices will be installed on all listed vehicles or on all county vehicles.**
2. Can you please provide a list of the vehicles by type, description, make, model, VIN so that we can determine which hardware solution would be optimal for each respective vehicle?
  - a. **Please see the attached list.**
3. Can you also please provide information as to whether it is the County's desire to capture data from specific inputs on the vehicles, e.g. plow, spreader, PTO, mosquito fogger, etc.?
  - a. **It is not the county's desire to capture data from any specific inputs on vehicles such as the ones listed in the question.**
4. Would the Jones County Board of Commissioners consider a telematics solution?
  - a. **Yes.**
5. How many pieces of heavy equipment do you anticipate have GPS devices installed?
  - a. **If the County opts to have the devices installed on heavy equipment, we have approximately 25 pieces of heavy equipment that would need devices. Please note that the County does not guarantee that quantity.**
6. Are you with Sourcewell (fka NJPA)?
  - a. **Yes. Member Number 21215.**
7. Is there a format to the proposal other than the questions and forms included with the 13 page document?
  - a. **No.**
8. Is there a term period for the contract awarded, like 2 year or 3 years or are you asking for a month-to-month?
  - a. **At this point, this is TBD. If your company has varying rates for different durations, please provide that information in your proposal.**
9. Do you have the number of vehicles and types (passenger, medium duty, Heavy Duty)?
  - a. **Please see the attached list.**
10. Is there a need for any winter operations support (plows, spreaders etc.)?
  - a. **No.**
11. Is there a need for any auxiliary or PTO measuring (dump lifts up or down, paint stripper on or off, etc.)?
  - a. **No.**



12. On the heavy equipment (bulldozers, excavators, etc.) is there a need for AEMP 2.0 data? Or just weather proofed tracking equipment and perhaps auxiliary measuring?
  - a. **There is not a need for AEMP 2.0 data.**
13. Our fleet device communicates every 2 minutes and most clients are happy with that. We can reduce this time period if you want but that will affect the monthly cost due to the amount of data transmitted. Let me know if 2 minute increments is fine.
  - a. **We request that the device communicate at least every minute.**
14. Are there other assets Jones County may want to track, e.g. trailers, forklifts, manlifts, etc. Quantity?
  - a. **No.**
15. When is it expected that a bid winner will be selected?
  - a. **Current plans are to have the award on the March 17<sup>th</sup> Commission Meeting agenda. In the event that the evaluation of the proposals takes longer than expected, the award may be pushed back to either April 7<sup>th</sup> or April 21<sup>st</sup>.**
16. Will there be cameras?
  - a. **No**
17. Would it be possible to wait until contract for services has been awarded to finalize the subcontractor affidavit?
  - a. **Yes**
18. Is this a new installation program or a replacement of an existing system? If replacement, can you tell us who the current provider is and why you are looking for a new solution?
  - a. **Installation of a new system.**
19. What are your priorities for information from the system? As you know, these systems generate a ton of data- what's important is what you need to know and what actions you want to take based on this information. We can work with you in this during set-up if you are still thinking this through.
  - a. **Location is our top priority. Beyond that, we are still working through this.**
20. Installation resources: do you have a dedicated resource for a "train-the-installer" option?
  - a. **We do not.**
21. API capabilities: do you need an interface to other enterprise systems? If so, can you let us know what you want to connect the data to?
  - a. **No**
