This Addendum is part of the Contract Documents for the above referenced project and modifies the original drawings and/or specifications, dated **1/20/23**, as noted below. The bidder shall acknowledge receipt of this Addendum in the place provided in the Bid Form. The published bid date and time shall remain the same.

GENERAL:

1. The bid form has been modified to include a request for a unit price per LF for additional asphalt crack repair beyond the assumed 500 LF.

SPECIFICATIONS:

1. Specification section 041113 Bid Form: Replace with current Bid Form section attached herein.

DRAWINGS:

- 2. Remove sheet **C-002 Demolition Plan** in its entirety and replace with the attached revised sheet. This sheet was modified to show the exiting pole vault runway shall remain as is, add a mesh paving fabric to the existing crack repair system, to assume 500 LF of crack repair and to repair washed out/damaged areas around the existing storm structures prior to the asphalt overlay.
- 3. Remove sheet **C-100 Layout Plan** in its entirety and replace with the attached revised sheet. This sheet was modified to show the exiting pole vault runway shall no longer receive an asphalt overlay or track surfacing/striping, and an expansion of the existing sand pit with a new 6" wide timber curb around the perimeter and supplemental sand.
- 4. Remove sheet **C-101 Surfacing and Dimension Plan** in its entirety and replace with the attached revised sheet. This sheet was modified to show the exiting pole vault runway shall no longer receive an asphalt overlay or track surfacing/striping, and an expansion of the existing sand pit with a new 6" wide timber curb around the perimeter and supplemental sand.
- 5. Remove sheet **C-600 Site Details** in its entirety and replace with the attached revised sheet. This sheet was modified to show a detail for the expansion of the existing sand pit with a new stacked 6" x 6" timber curb around the perimeter and supplemental sand.
