  - A separate RFP for External Financial Audit Services is forthcoming. A firm may hold either the contract resulting from this current solicitation for Internal Audit Services or the upcoming External Audit Services contract, but not both.
- Tomeka turned over the meeting to the Project Officer for an overview of the Scope of Services. Project Officer explained the project and highlighted the work to be done.
  - The Contractor shall provide all necessary labor, supervision, supplies, materials, and equipment to properly perform internal audit services.
