This addendum will amend **<u>RFQu #21-003</u>**, <u>Environmental and Wetlands Engineering</u> <u>Services, IDIQ</u> originally issued on Wednesday, December 30, 2020. This clarification is being provided to all known and registered correspondents in response to questions received. Question #1: The County has an apparently strict preference for local contractors. Will large contractors that provide value and service potential for the County be considered even if they do not have a local presence in Georgetown County but are present in SC?

Response: This was answered in addendum #1. See addendum #1, Q & A #6.

- **Question #2:** Does Georgetown County have preference regarding the training provision of this contract? In other words, does the County prefer that the successful vendor conduct formal "classroom" training sessions with County staff or is the preference for mentor training while the staff conduct work alongside the vendor's staff while completing work orders?
- **Response:** Mentor training is adequate.

Question #3:	Is Georgetown County currently under any enforcement actions from state or federal agencies for non-compliance with previously issued permits or actions that failed to obtain necessary permits?		
Response:	No, not to our knowledge.		
Question #4:	: Is there an incumbent for this contract? If so, who is the incumbent?		
Response:	The previous contract was with the Brigman Company as stated on page 3 of the Request for Qualifications.		
Question #5:	What was the total dollar value and length of term for the previous contract?		
Response:	The dollar value of the previous contract was \$32,665.00. The term of the previous contract was 5 yrs. as stated on page 3 of the Request for Qualifications.		
Question #6:	For staff billing rates, do you need all staff rates or just the rates of the prime consultant?		
Response:	We need all staff rates.		
Question #7:	How many projects were assigned/completed during the last On-Call?		
Response:	There were 8 task orders.		
Question #8:	Language in the RFQ indicates there are expectations for wetland/stream compensatory mitigation. Is the intent to assist in obtaining credits from existing banks? Or to establish Permittee-Responsible Mitigation or a single-client mitigation bank for Georgetown County projects?		
Response:	Assist with obtaining credits from existing banks.		
Question #9:	Is the training component for County staff intended to be a formal classroom setting or providing "on the job" training as projects are completed?		
Response:	On the job training in the field.		

- **Question #10:** Does this On-Call pertain to a specific type of project in Georgetown County (ie. transportation projects, waste water treatment, or stormwater management) or is the intent to provide environmental services for all projects completed by any department of Georgetown County?
- **Response:** It is intended for all applicable projects needed by Georgetown County.
