This addendum is hereby incorporated into the Bid Documents for the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. 1. Questions & Answers:

Q1: Can Daytona Dock & Seawall Service, Inc bid the project as a specialty marine contractor even though the President Robert E. Bonner is not a general contractor, but as a state certified residential contractor he has qualified this corporation as a specialty marine contractor dealing with all phases of residential and commercial seawall installations for over 40 years. References would include Crane Materials Inc (CMI) which is listed as a supplier of the composite sheet piles for this project. On their website is shown a 1,000 ft long ocean seawall utilizing their product that Daytona Dock & Seawall Service, Inc completed during the hurricane season of 2004/2005. Also using their composite sheet piles was built an oceanfront seawall replacement at the Marine Terrace Condo just north of University Dr. in Daytona Beach. Multiple seawall replacement projects over the last 40 years can at anytime attest to the structural and financial stability of this corporation.
