



PART 2 Execution

2.01 Measurement and Payment of Bid Items

A. Remove and Replace 6-30 Curb and Gutter

1. Measurement of this item shall be paid by linear foot (LF) of 6-30 curb and gutter constructed in place and approved. Measurement shall be made on the surface of the new curb and gutter from the lines formed by the junction of the new concrete and old concrete. This item shall include excavation, fill, sod, forming, concrete, **asphalt**, and all other materials needed to perform work. Payment shall be made by the contract unit price per Lineal Foot (LF) in place and approved.

B. Remove and Replace ADA Ramps

1. Measurement of this item shall be paid by each (EA) ADA concrete ramp constructed in place and approved. This item shall include excavation, backfill, sod, forming, concrete, truncated domes, concrete curb and gutter and all other materials needed to perform work. Payment shall be made by the contract unit price each (EA) in place and approved.

C. Furnish and Install 6-18 Vertical Curb

1. Measurement of this item shall be paid by liner foot (LF) of 6-18 curb constructed in place and approved. Measurement shall be made from the lines formed by the junction of the new concrete. This item shall include excavation, , gravel base, compaction, reinforcement, fill, sod, forming, concrete, and all other materials needed to perform work. Payment shall be made by the contract unit price per Lineal Foot (LF) in place and approved.

D. Furnish and Install Concrete Slab

1. Measurement of this item shall be paid by cubic yards (CY) of concrete slab constructed in place and approved. Measurement shall be made from the lines formed by the new concrete. This item shall include excavation, gravel base, compaction, reinforcement, forming, concrete, finishing and all other materials needed to perform work. Payment shall be made by the contract unit price per Cubic Yard (CY) in place and approved.

E. Furnish and Install Backfill (Sand)

1. Measurement of this item shall be by the number of tons (TON) of select backfill furnished and installed in place and approved. Quantities shall be verified and paid by haul ticket. This item includes excavation, disposal of existing material, furnishing and installing
