We have reviewed the seven (7) bids received for the City of Sebring - Caddy Shack - Golf Cart Buildings, ITB#18-013. The apparent low bidder was Chapman's Construction Company, Inc. at \$311,855.00, three hundred eleven thousand eight hundred fifty-five dollars and no cents. Within the bid the Contractor provided an alternate for Wayne Dalton Mod-U-Wall partition walls which would result in a \$7,800.00, seven thousand eight hundred dollars and no cents, credit on the Lump sum bid. To the best of my knowledge this bidder is qualified to do the work.

It is our recommendation that if the insurance and bond requirements are met, that the project be awarded to the low bidder Chapman's Construction Company, Inc. for \$311,855.00, three hundred eleven thousand eight hundred fifty-five dollars and no cents.
