REVISION:

Due to some confusion regarding the NFPA 110 specifications, it has been brought to our attention that not all models listed in the bid document are NFPA 110 capable. Therefore, for bidding purposes and fair comparison, please quote the models or equivalent as indicated in the bid document. Per the County Fire Chief, NFPA 110 requirements will be waived as long as it meets the Georgetown County adopted Electrical Codes. No further questions, clarifications, or addendums will be issued. If it is later on discovered that this is a grant requirement and models need to be adjusted, we will do so with the awarded bidder, if needed.

2nd BID OPENING CHANGE: Due to the late issuance of Addendum #4, the bid opening date will be pushed back once again to allow time for bids to be received from vendors. No further questions will be received. The new timeline is listed below. Please keep in mind, County offices will be closed on Monday, November 11, 2019.
