This will be used as the basis for negotiations should your firm be selected as the highest ranked offeror. Only the Cost Proposal from the highest ranked firm will be opened.

Sealed bids to provide **Land Surveyor Services** shall be received electronically through the County's Vendor Registry webpage until the cut-off time Bids will then be promptly opened at the designated time by the Buyer. Bids that are not received prior to the stated opening date and time will be considered **NON RESPONSIVE**.
