ADDENDUM SIX EAST LAKE PARK IMPROVEMENTS WATER QUALITY PROJECT CONTRACT NO. S-15-016 CITY OF CHATTANOOGA, TENNESSEE

The following is in response to Request for Information:

1. **Question** – Request an extension for the bid due date of December 18, 2018.

Response – Yes, the Bid Opening date has been adjusted to Tuesday January 8, 2019. All other associated information regarding time and location remains the same.

Addendum #5 included reference to an updated Bid Schedule and Measurement and Payment form to include updates issued via addendum.

The following is a summary of updates and the new Schedule and Spec Section are attached:

- In the previous addendum, the Owner and Engineer agreed to modify the bid schedule to change the unit cost item for Concrete Pond Bottom repairs to an allowance because of uncertainty related to the quantities and scope of repairs. This change has been made. Attached to this addendum is a re-issued Bid Schedule with an allowance of \$30,000 for concrete bottom repairs.
- 2. The measurement and payment description for the Concrete Pond Bottom repairs item (Item 3.07) has been replaced in its entirety with the following:

The Concrete Pond Bottom Repair Allowance is to provide reimbursement for furnishing all labor, material, equipment, and services required for pond bottom damage repairs and pond perimeter concrete repairs necessary to maintain an impervious pond bottom. The Allowance will be included as part of the awarded Contract amount. However, the Allowance is not part of the contract and is not due to the Contractor except when authorized pond bottom repairs are necessary during construction activities. Once the pond is drained and the sediment is removed, the Contractor and Engineer will inspect the site and identify damaged areas that need to be repaired. The Contractor will prepare and submit an estimate to complete the repairs. Only repairs approved by the Owner and Engineer prior to the Contractor initiating the work will be reimbursed at the negotiated cost using this allowance. The balance of the Allowance remaining at project completion shall remain the Owner's and will not be paid to the Contractor.

- 5. Payment for furnishing all labor, material, equipment, and services required for demolition and installation to complete the maintenance building electrical modifications on Sheet E-3 of the Drawings shall be paid at the lump sum price in the Bid Schedule.
