GENERAL CLARIFICATION

1. Regarding ES1.1 and ES1.2: All of the (16) perimeter pedestrian streetlight poles will require the contractor to enter into the partnership agreement with the City and pay the fee of \$40,475.68 (2,529.73 each). This fee covers the pole, luminaire, wiring and installation for these (16) lights but excludes installation of the foundation, conduits and installing pull boxes (supplied by EPB). All other items shown on the electrical schedule shall be sourced and supplied by the electrical contractor.
