This addendum answers questions raised about this solicitation. To aid in readability, the questions are in black, the answers are in **bolded blue**, and the answers follow immediately below.

Q1	Is there supposed to be a space on Solicitation Document G for a total project cost?					
Q1	Yes. Please use the revised Solicitation Document G in this document.					
Q2	During the pre-proposal conference, you discussed having the awarded proposer under contract for					
ŲΖ	additional similar work that arises in the future. Please further discuss.					
	KCDC may have additional needs for these types of services in the future. Therefore, KCDC asks proposers to submit a proposal for pricing of future work which may have different configurations, topography, et cetera. Proposers are to provide a narrative describing in detail how pricing for future work would be determined. KCDC may accept the proposal, reject the proposal and/or negotiate the terms of the proposal as it sees fit. If this portion is awarded, when future needs arise, KCDC may engage the successful proposer under the terms/pricing scenario outlined in this RFP.					
Q3	Are the shingles for the porches provided?					
	No. The successful proposer will purchase Certainteed Landmark Weathered Wood to shingle the porch roofs. The proposer will supply Hip and Ridge, felt and venting materials as well. KCDC has posted the "cut sheets" for the shingle to its webpage.					
Q4	Discuss the water and electric meters and who pays for what.					
	KCDC will apply for the water/sewer and electric service for each lot. Associated fees (application fee, tap fee, water meter) will be paid by KCDC.					
Q5	Please explain what permit/tap fees the proposer will be responsible for?					
	After more discussion, KCDC decided it will cover the cost of all of the building permits/tap/service connection fees.					
Q6	Did you mention an additional insured to be added to Certificate of Insurance?

Q7	Will KCDC/KHDC allow 120 days for completion instead of 100 days?					
	KCDC will allow 120 days for completion of the project, however Certificates of Occupancies (CO's) for phase 1 (lots 20-28) must be received within 90 days after the Notice to Proceed is issued.					

Q8	Concerning the usage of a crane, are there safety clearances to be observed? Does the proposer need to plan on turning the power off to the lines?			
	Yes. The contractor/crane operator is responsible for notifying KUB prior to taking delivery of the			
	modular units. The minimum distances from the transmission lines are to be adhered to per KUB			
	regulations.			
Q9	Can you provide a production schedule for the buildings that Clayton will be producing?			
	Clayton will have the first phase, lots 20-28 completed no later than the end of April. Clayton will			
	coordinate with the awarded proposer on when they will need the remaining units for the other			
	phases. It takes Clayton approximately two weeks to produce and ship each phase.			
Q10	When does the site preparation contract work start and end?			
	The work started on 03-04-19 and ends in approximately 60 days. The site contractor is working			
	from the top of the site, to the bottom.			
Q11	What are the HVAC certification requirements?			
	KCDC has posted the Energy Star Guidelines for Modular Housing to its webpage. These are the			
	Energy Star Guidelines that the HERS rater is following on this project. Most of these items are for			
	the production plant but the highlighted sections pertain to the on-site work under this			
	solicitation. Since the proposer will be installing the floor insulation at the site, they are required			
	to follow these specifications to ensure installation to RESNET Grade 1. Since some ductwork and			
	the heat pump units are to be installed at the site, the HVAC subcontractor is required to adhere			
	to the minimum R factors in Section 5 and to having the required accreditation to perform the			
043	work.			
Q12	Are you changing the bid envelope coversheet?			
	Yes. Please see the attached revised Coversheet and use it instead.			
Q13	Is removal of the sediment basin in the scope of work for the site work contractor?			
	No, removal of the sediment basin is in site contractor's scope of work (not this solicitation).
