# FIRE ALARM REPLACEMENT AIRPORT HIGH SCHOOL LEXINGTON SCHOOL DISTRICT TWO ELECTRICAL ITEMS - ADDENDUM #1 October 30, 2018

This addendum modifies the Contract Documents only in the manner and to the extent stated herein and shown on any accompanying drawings and will become a part of the Contract Documents. Except as specified or otherwise indicated by this addendum, all work shall be in accordance with the basic requirements of the Contract Documents.

#### **GENERAL:**

#### 1. CLARIFICATION OF PRE-BID QUESTIONS:

- The fire alarm cable must be run in conduit per the requirements of the SC Office of School Facilities Design Guide, and per the Contract Documents.
- The system may be partially operable during construction provided areas where system is not operable are either unoccupied by students/faculty or a proper fire watch for that area is established during the time the fire alarm system in that area is not operable.
- An equivalent FACP and equivalent fire alarm initiating devices as manufactured by Gamewell/FCl or Notifier may be provided in lieu of reusing the existing EST3 FACP and initiating devices.
- Voice intelligibility is not obtainable in all spaces, refer to the FIRE ALARM SPEAKER TAP SCHEDULE on E601.
- Specific device counts are not available, refer to Bid Documents for locations, quantities, etc.
- See Sheet E001 and page 1 of 260500 for allowances, unit prices, and spare parts required as part of this project.

#### 2. CLARIFICATION OF PRE-BID QUESTIONS:

- The school will be made available for work after school hours & evenings M-F, and with prior notice and agreement of all parties, at night, on weekends, and during holidays. In some instances, certain areas may be available during normal hours with prior notice. Contractor shall schedule work with school district ahead of time and shall provide a written (or pdf) Phasing Plan/Work Schedule prior to starting work. Phasing Plan/Work Schedule shall be updated weekly as needed to reflect changes.
- The existing EST horn/strobe fire alarm system shall remain in operation during construction. When speaker/strobes are added in an area, they shall be fully operable and tested prior to removal/demolition of the existing horn/strobes. If the existing EST fire alarm system is rendered inoperable in an area while that area is occupied by students, faculty, and/or parents it shall be the Contractor's responsibility to provide a "fire watch" in the areas of the building where the existing system is down. As long as the existing fire alarm system is operable, a "fire watch" is not required. If an area is vacated (such as over Christmas Break) a "fire watch" is not required.

UNIT PRICE #6: Wall mounted Manual Pull Station.

<u>UNIT PRICE #7:</u> Ceiling mounted Smoke Detector or Heat Detector.

UNIT PRICE #8: Monitoring Module.
UNIT PRICE #9: Magnetic Door Holder.
