2 **A RESOLUTION OF THE CITY COMMISSION OF THE CITY**
3 **OF PARKLAND, FLORIDA, APPROVING THE EVALUATION**
4 **COMMITTEE'S RANKING AND AUTHORIZING THE**
5 **PURCHASING DIRECTOR OR DESIGNEE TO NEGOTIATE**
6 **AND EXECUTE CONTRACT WITH THE TOP-RANKED**
7 **PROPOSER, CENTER FOR PUBLIC SAFETY MANAGEMENT,**
8 **LLC, FOR SECURITY CONSULTANT SERVICES; AND**
9 **APPROVING FOR AN EFFECTIVE DATE.**

11 **WHEREAS**, in accordance with the City of Parkland's ("City") Procurement Code, City
12 Staff advertised, on March 30, 2018, a Request for Proposal (RFP # 2018-20) for Security
13 Consultant Services; and

15 **WHEREAS**, on April 24, 2018, the City received five (5) proposals received from
16 Mission Critical Partners, LLC, Elert & Associates Networking Division, Inc., Fitzgerald
17 Technology Group, LLC, Center for Public Safety Management, LLC and Michael Greene &
18 Associates; and

20 **WHEREAS**, on May 17, 2018, the Evaluation Committee reviewed, rated and shortlisted
21 the top three (3) proposals based on the criteria outlined in the RFP; and

22
23 **WHEREAS**, the shortlisted three (3) proposals were respectively Center for Public
24 Safety Management, LLC, Elert & Associates Networking Division, Inc. and Fitzgerald
25 Technology Group, LLC; and

27 **WHEREAS**, after further discussion and review of the criteria set forth in the RFP, the
28 Evaluation Committee unanimously recommended approval of the top-ranked proposer, Center
29 for Public Safety Management, LLC; and

31 **WHEREAS**, the Evaluation Committee is recommending the Purchasing Director or
32 designee to negotiate terms, condition and fees, and execute contract with the top-ranked
33 proposer, Center for Public Safety Management, LLC, for security consulting services.

35 **NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY**
36 **OF PARKLAND, FLORIDA AS FOLLOWS:**

38 **Section 1.** The foregoing "WHEREAS" clauses are confirmed and ratified as being true
39 and correct and are hereby incorporated herein.

41 **Section 2.** The City Commission hereby approves the Evaluation Committee ranking of
42 the Security Consulting Services and authorizes the Purchasing Director or designee to negotiate
43 terms, conditions and fees, and execute contract with the top-ranked proposer, Center for Public
44 Safety Management, LLC.

46 **Section 3.** In the event the Purchasing Director or designee is unable to negotiate a
47 contract deemed to be acceptable with the top-ranked firm, the Purchasing Director or designee
48 shall report to the City Commission which shall either require that the Purchasing Director or
49 designee continue negotiations or authorize negotiations with the second-ranked firm until the
50 process is complete or, until the Purchasing Director or designee or the City Commission
51 determines that it is no longer feasible to continue negotiating; at any time the City Commission

52 has the full discretion to either abandon the process or begin the process again.

54 **Section 4.** The RFP packet has been reviewed and approved by the City Attorney.

55

56 **Section 5.** This Resolution shall become effective immediately upon adoption.
