The purpose of this Addendum #01 to IFB 23-B0045 for 38th Avenue North Fire Signal dated May 9, 2023, is to list the key points of discussion from the mandatory pre-bid meeting, provide the Business Survey, and provide the sign-in sheet.

- Section 2.03 of the Terms and Conditions that declares that clarification must be requested from the Bidder not less than three (3) days is hereby changed to five (5) City business days. All questions and requests for clarifications must be received, in writing, by the Buyer no later than Tuesday, May 16, 2023 at 5:00PM.
- Section 12.03 of the Terms and Conditions is hereby changed from three-hundred sixty-five (365) days to ninety (90) days for project completion from the issuance of the Notice to Proceed. The Notice to Proceed will be issued at the Contractor's discretion, contingent with lead times for the mast and arms.
- Liquidated damages are five-hundred (\$500.00) per day.
- Night work will be permitted for this project.
- The access to the fire station must be open at all times.
- The sign-in sheet is attached and is hereby made a part of this addendum.
