QUESTIONS FROM OFFERORS:

- 1. **Question**: Will the delay of game timer sites already have power available to tie into, or is this to be brought to each site by the vendor? If so, what is the nearest power source for each dock?
 - **Answer:** Power can be pulled from the current scoreboard location for the DOG timer on the east side and from the Visitor concession on the west side. HCS will pull power from the interior to the exterior of the building. Contractor will be responsible for supplying the remaining run
- Question: What needs to be done with the current speakers on the scoreboard? Answer: They need to be removed and disposed of by the contractor.
