In the ITB, under the Contract Terms and Conditions section, it states that a Bid Bond in the amount of 100% will be required to be submitted with the bid. Is this percentage correct? If not, please provide the percentage required. Documents state that a bid bond of 100% is required. Should this read 10%	The IFB erroneously states that a bid bond in the amount of 100% of the bid price shall be submitted. The required amount should be 10%.	
Will there be a pre-bid meeting held? If so, please provide specifics.	There is no pre-bid meeting scheduled.	
Are the only documents required to be submitted as our part of the bid the: bid form, pricing schedule and bid bond?	The bid form notes that a schedule of major milestones with a duration not to exceed 150 days from NTP is also required to be submitted, in addition to the bid form, pricing schedule and bid bond.	
On sheet C501 Drainage, there is no data shown, e.g. inverts, pipe size, etc.	Sheet C-501 Drainage had the wrong detail shown in AutoCAD. The correct detail is now shown and the revised drawings have been uploaded to Vendor Registry.	
Can you please provide a distributor for the removable bollards?	The Town is specifying the use of Bollard Solutions for their manual retractable bollards, model number
