Additional information to add from pre-bid meeting.

- Needed to specify that the removable center posts for all double doors be a KR4954.
- We discovered that there were 2 doors that the cinder block above the doors had bad mortar joints and they will require lintels prior to the new doors and frames being installed.



Description

A lintel is a structural horizontal block that spans the space or opening between two vertical supports. It can be a decorative architectural element, or a combined ornamented structural item. It is often found over portals, doors, windows and fireplaces.

- We also request the contractor install new brush type door sweeps at the bottom of each new door.
- I Forgot to include replacing the single storage room door located next to JV Locker Room. This door needs to be replaced with a solid hollow metal door with no window. The new door shall have a LCN model 4040XPH closer, and be key entry with an exterior closet function handle.
- Also need to include replacing the Aux Gym mechanical room double doors. New frame must have removable center post. Post shall have lock/core that is keyed to the Fort Mill School District lock and key system. New doors shall have vents/louvers to allow air flow into mechanical rooms. Both new doors shall have Von Duprin 99 series exit devices. One of the doors shall be key entry and other shall have just pull handle on the exterior. Contractor will supply Corbin Russwin 6 pin Interchangeable Core (IC) cylinders for both doors.
