Question 1:

Can the City provide any construction drawings (or GIS link) of the existing sanitary sewers on 4th St., Main Ct and 3rd St.? We understand there are concerns with the integrity of the sewer under the Nimishillen. It would be helpful to view the sewer location/grades to understand if the scope for an aerial crossing can be accomplished by gravity? Is that what the City has already determined? Our question is related to the potential of a pump station or not.

Question 2:

Can the City provide any information on the basis for the sewer replacement? Is this a complete replacement due to age or deterioration? Was this based on CCTV inspection and can the City provide that inspection log or video? Does the City anticipate leaving the sewer in place/abandon or do you anticipate the ability to pump around and install the replacement sewer in the same location? Is this capacity-related and the new sewer is to augment the existing as a relief sewer?

Question 3:

As complete replacement, is it safe to assume all connections will be replaced as well to the R/W and connected to the new replacement sewer?

Question 4:

The route description on Pg. 2 of 4 describes a new sewer on 3rd St. from Main to Warner necessitating another creek crossing. This is not mentioned in the RFQ; can you confirm please? We assume there is no bridge replacement at that location.

Answer:

The bridge on 3rd St. SE is a recently constructed pedestrian bridge. The bridge on 4th St. SE is to be replaced under a separate contract. Both are under the Canton's jurisdiction. There is an existing siphon on 3rd St. SE that may be abandoned - to be determined.

Question 5:

At what phase of planning or design is the 4th St. Bridge Replacement project? Are the bridges on 4th St. and 3rd St. owned and maintained by the City? There is a reference to ODOT in the RFQ that we are unclear about.

Answer:

The bridge on 3rd St. SE is a recently constructed pedestrian bridge. The bridge on 4th St. SE is to be replaced under a separate contract. Both are under the Canton's jurisdiction. The bridge replacement project on 4th St. SE is in the preliminary study phase.

The pavement condition is poor; does the City anticipate the inclusion of improving the roadway as part of the project?
