Questions & Answers

Q1. In Section 2.0 INSTRUCTIONS FOR RFQ

- States "All responses to the RFQ, in the form of A Letter of Interest (LOI) and a Qualification Package (QP)"

The rest of the RFQ only refers to a QP, and not an LOI. Is the LOI considered to be the cover letter included as part of the overall QP package, or is it supposed to be a separate document? If so, are there parameters for what should be included in an LOI?

A1. Yes, the LOI is considered to be the cover letter submitted with the QP package.

Q2. In Section 3.0 QUALIFICATION PACKAGE CONTENTS

- 3.2, part D (page 11) states "A copy of a Standard Form 330, Architect-Engineering Qualifications, Part I & II" should be included.

Does this document count toward the overall 25-page limit for the QP?

A2. Disregard 3.2, part D

Q3. In Section 3.0 QUALIFICATION PACKAGE CONTENT

If this document is included, do you also want staff resumes and project experience to be detailed in the form, even though a staff resumes and previous experience for similar projects will already be included in 3.2, parts B & C?

A3. Provide staff resumes and project experience in 3.2, part B & C.

Q4. In Section 3.0 QUALIFICATION PACKAGE CONTENT

- Please confirm that 3.4, 3.5, 3.6, 3.7 and 3.8 are for the consultant's reference only, and do not indicate required sections under the PROPOSAL SCOPES OF WORK Tab as part of the consultant's QP.

A4. Yes, 3.4, 3.6, 3.7, and 3.8 are information related to the terms of conditions for the Continuing On-Call Professional Service contracts to be established by this RFQ. For 3.5 see below

Q5. In Section 3.0 QUALIFICATION PACKAGE CONTENT

- 3.5 (page 12) specifies that the "Consultant shall provide documentation that the firm is of sound financial standing and has the financial ability to work in the capacity of Continuing On-Call Professional Structural Engineering Services."

Is this to be submitted as part of our QP?

A5a. On 3.5 a financial document shall be provided to show the firm's financial ability.

If it should be submitted as part of the QP, does it count toward the 25 page limit for the package?

A5b. Yes, it does count as one of the 25 pages.

Q6. Will a monthly stipend be offered for the continuing on call services, or compensation only for projects as they are assigned?

A6. Compensation for projects as they are assigned.
