This addendum is being issued to revise the solicitation to extend the bid deadline and address questions received.

1. The Bid Deadline has been revised to June 29, 2018 at 3:30 pm.

**Questions and Answers**

1. What can the Contractor do with the extra fill dirt removed?

**Answer:** Two property owners have indicated they would take the fill and allow it to be piled up at the locations within a mile from the site. These agreements are in the process of being reviewed and approved.

2. The Section 00836 Waiver of Right to Claim Against the Public Construction Bond is required to be submitted with the bid per addendum 4 however this document as it states in the first sentence is not required until "consideration of final payment". If the bidder has yet to perform any work how can this document be required with bid submittal?

**Answer:** The Waiver of Right to Claim Against Public Construction Bond will not be required with the Bid submittal. See the attached page from the solicitation with the form shown in strike through format and deleted. This form will be required from the successful Contractor at the appropriate time.

3. I have one additional questions relative to this bid. Addendum No.5 included the attached Statement of Indemnification which materially changes the indemnification provided in the contract agreement. Will HCBCC allow Bidders to provide a red-lined version of this document with our bid? If not, does the Engineer fall under the classification of HCBCC's "agent"?

**Answer:** This will correct Addendum No. 5 Item # 2 (on page 1 of 11). The indemnification form is not required with the bid. The sample contract covers the indemnification that the successful bidder will be required to provide at the time of contract. See the page 1 from the Addendum #4 attached which shows in strike through format that this indemnification is not requirement at the time of the Bid.

### Questions and Answers

1. Article 14 is Basis of Bid. There are 2 lump sum bid forms A & B. Can the contractor assume that the low responsive bidder will be awarded the entire project based on the total value or A&B, or can the scopes be awarded separately?

**Answer:** The Bid Form is divided by the work into A & B in case the work does not proceed together. The award will be made to the lowest responsive and responsible bidder with the combined A & B Total Lump Sum Price.
