Without sufficient information, this requirement will increase contractor's risk and cause increased cost to the Owner that may not be necessary. Please provide an allowance to accommodate for additional work that may be encountered due to existing foundations.	There is no additional information available regarding the existing foundations. The Contractor is to include in their bid the effort required to remove the foundations as necessary to comply with the contract documents.
