Question #1: On page 4 of the RFQu, under Mandatory Forms, “Questionnaire” is listed as a mandatory form along with Resident Certification for Local Presence, etc. Should a questionnaire be attached to the RFQu?

Response: No, the proposed Questionnaire was removed from the solicitation before it was posted so it is no longer a Mandatory Form.

REVISION: See revised weighted criteria below.

Weighted Criteria:

It is the intention of the evaluation committee to select the consultant most capable of providing the necessary services. The following criteria will be used during the evaluation and selection process.

1. Firm's understanding of the project objectives.....20 pts.
 2. Firm's recommended approach to the project.....15 pts.
 3. Qualifications of principal(s) to perform the work and the level of involvement in the project.20 pts
 4. Firm's knowledge and demonstrated experience with county jail design, construction, and operations planning. Per the County's local preference ordinance, firm's physical office location will also be a factor in this weighting.....25 pts.
 5. Firm's ability to provide turnkey, comprehensive solutions....20 pts.
