This addendum will amend <u>Bid No. 20-062, Indian Hut Road & Amos Road Extension Paving</u> <u>Improvements</u> originally issued on Wednesday, December 30, 2020. This clarification is being provided to all known and registered correspondents in response to questions received. All addenda and original solicitation documents are also available online at: <u>www.gtcounty.org</u>, select "Bid Opportunities" from the Quick Links section and "View Current Bid Solicitations."

Question #1: Please clarify the required RCP pipe type and bedding type.

Response: Pipe shall be RCP with Profile Gasket (AASHTO M315, ASTM C443). Tongue and groove pipe is not acceptable.

Pipe bedding shall be #57 stone (minimum 6" depth under the pipe) and shall extend up to the top of the haunch of the pipe.

Each pipe joint shall be wrapped with non-woven geotextile fabric to prevent migration of soils into the pipe, extending 12" on both sides of joint and overlap at least 18".

Pipe, bedding, backfill and fabric wrap at joints shall all be included in the unit price of the pipe.
