2. The Bid Deadline has been revised to October 14, 2019 at 3:30 p.m.

Questions and Answers:

1. Pay item #11 calls for 1 ½" SP-9.5 but page 4 of plans calls for 2" SP-9.5. Could you please clarify?

Answer: There is an error on Division 0/Section 00300-4 (specifically page 30). Instead of 'SUPERPAVE ASPHALTIC CONCRETE, TYPE SP-9.5, 1½" COMPACTED THICKNESS (RAP 30% MAXIMUM), ROADWAY & DRIVEWAY', it should be 'SUPERPAVE ASPHALTIC CONCRETE, TYPE SP-9.5, 2" COMPACTED THICKNESS (RAP 30% MAXIMUM), ROADWAY & DRIVEWAY' for Task No. 11.

Contractors are to complete and submit the revised Bid Form attached to this Addendum.

Bidder acknowledges that County and Project Manager do not assume responsibility for the accuracy or completeness of information and data shown or indicated in the Bidding Documents with respect to Underground Facilities at or contiguous to the Site. The alternate is to provide all labor, materials and equipment for the construction of Interlake Boulevard. This alternate requires the CONTRACTOR to use asphalt from the Highlands County owned asphalt plant for the construction of the project. The CONTRACTOR shall be responsible for retrieving the asphalt from the asphalt plant and for placing the asphalt at contractor's cost. CONTRACTOR shall not be charged for the asphalt.
