The line item pricing format on the bid form is changed to lump sum project pricing. The lump sum bid shall include the entirety of the video system being proposed, including all equipment, hardware, software, installation materials and labor, and training as specified. The requested annual maintenance agreement shall be the only item priced separately.

An itemized price sheet shall be attached to the lump sum bid. Specifications for the proposed equipment must be attached to the bid.

All cameras proposed shall have, at minimum, the frame rate capability of 15 frames per second. All cameras proposed shall have motion-activated recording. The list of camera locations discussed during the pre-bid meeting walkthrough is as follows:
