This addendum is hereby incorporated into the Bid/Proposal documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by <u>underlining</u>, deletions are indicated by <u>strikethrough</u>.

1. RFP General Conditions, Page 5 of 33, Evaluation Criteria is hereby DELETED and REPLACED with the following:

16. EVALUATION CRITERIA

A. Firm's Qualifications, Experience, and Ability to Complete the Work.

Submittal Requirements:

Provide a summary of 5 similar projects performed in EPA Region IV. Each project presented has the potential of earning a half point or a full point. In order to be considered for a half point, 2 of the following 5 elements must have been successfully completed on that project by the proposing firm. In order to be considered for a full point, at least 3 of the following 5 elements must have been successfully completed on that project by the proposing firm.

Projects must have been completed no earlier than 1/1/2000. Include a summary of the Scope of Work, the start and end dates of service, owner name and contact information, contractual relationship to project owner (i.e., Prime Consultant or Sub-Consultant).

Experience in all 5 elements must be demonstrated in the projects presented. For each element *not* represented in the 5 projects provided, a full point will be deducted from the score for this criterion.

- 1. Phase 1 and Phase 2 Environmental Site Assessment experience in working through the site rehabilitation process of Chapter 62-785, F.A.C. and/or American Society for Testing and Materials (ASTM) standard E 1527-05 and ASTM Std E 1903-97
- 2. USEPA Grant or FDEP Revolving Loan application, administration, and close-out

- 4. Brownfield site redevelopment, including experience with planning, concurrency, and land use on Brownfield Sites.

Submittal Requirements:

Provide a summary of 5 similar projects performed in EPA Region IV, for which the Project Manager served in the position of Project Manager. Each project presented has the potential of earning a half point or a full point. In order to be considered for a half point, 2 of the following 5 elements must have been successfully completed by the Project Manager on that project. In order to be considered for a full point, at least 3 of the following 5 elements must have been successfully completed.

Projects must have been completed no earlier than 1/1/2000. Include a summary of the Scope of Work, the start and end dates of service, owner name and contact information, contractual relationship to project owner (i.e., Prime Consultant or Sub-Consultant).

Experience in all 5 elements must be demonstrated in the projects presented. For each element below *not* represented in the 5 projects provided, a full point will be deducted from the score.

Submittal Requirements

Provide a narrative explaining the Proposer's approach to the Scope of Work. Include the Proposer's public outreach program and use of outside resources. Specify the outside resources to be used to complete the Scope of Work.

Evaluation Criteria

- Thoroughness of Proposer's understanding of the Scope of Work;
- Practicality and effectiveness of the Proposer's approach.
- Adequacy of use of a proven method of civic engagement.
- Effectiveness of use of outside resources.

Weight = 15
