**Kayak Launch at Thunderbolt Park**

The purpose of this Addendum 01 to IFB 24-B0011 for the Kayak Launch at Thunderbolt Park, dated October 2, 2023, is to list the key points of discussion from the mandatory pre-bid site visit.

- It is the intent of this Bid to build a Kayak Launch at Thunderbolt Park located at 2290 Farrow Parkway, Myrtle Beach, SC. Work to include:
  - The location of the kayak launch will be directly across from the front entrance of the City Parks and Recreation Building.
  - The work includes a complete dock system with a prefabricated kayak launch that is handicap accessible. System includes:
    - Ramp
    - Floating dock
    - Regular Kayak Launch
    - Handicap Kayak Launch
  - Pylons will be located in the water.
- Requests for substitution must be received at least ten (10) calendar days prior to date and time of bid opening. Requests received less than the ten (10) calendar days prior to date and time of bid opening will not be considered.
