1. I am requesting clarification on the Purate portion of your bid 2017-WP-01. We are manufacturers of chlorine dioxide generators utilizing sodium chlorite chemistry. In your bid, you indicate that equipment testing and service must be required. Are you accepting bids for sodium chlorite if it includes replacement of Purate (sodium chlorate) generators with sodium chlorite chlorine dioxide generators?
