**RFP Title: Inmate Medical and Behavioral Health**

The following are a list of questions and responses that were submitted regarding the above-referenced RFP.

**Question No. 1:** How are medications being dispensed by the current vendors? Can we get their schedule for medication dispensing for a 24-hour period?

**Response No. 1:** Medication is currently being distributed (crushed) at the detainee dayrooms. Medication is passed twice daily usually starting at 0800 and 2000 unless a medication is needed patient specific through out the day. We do operate a medication assisted treatment program which is distributed in the medical clinic prior to routine medication pass.

**Question No. 2:** What is the start and end of shift hours for the nursing staff (day/evening/night shifts)?

**Response No. 2:** Currently the medical shift is with the officers on a twelve-hour shift starting at 0500-1700 and 1700-0500. We, however, have no preference and leave the nursing schedule up to the contractor. We only ask that the shift does not interfere with the operations of the facility.

**Question No. 3:** Can we get the medical schedule of the current month and next month’s schedule?

**Response No. 4:** Currently we have a Health Services Administrator, Executive Assistant, one Mental Health Professional on site who is currently a LMSW, a Psychiatrist who is tele-psych, one MD which is tele and on site once a month, 3 EMT/Paramedics, and 2 RN’s. We currently have one LPN opening.

**Question No. 5:** How many emergency bags do the medical contractors have in the facility? How many emergency bags does the county recommend?

**Response No. 5:** We have one emergency bag, one AED, Stryker Gurney and One Life Pack.

**Response No. 6:** Approximately 1400

**Question No. 7:** Approximately how many clinic appointments are seen per year?

**Response No. 7:** Calendar year 2021, there were 2,528.

**Response No. 9:** Clinical, Class C. Yes, the facility has a DEA license.

**Question No. 10:** Is Grant County Detention Center's Pharmacy license(s) current and if they are when do they expire (please explain for all classes of licensures)?

**Response No. 10:** Yes, Expiration Date 09/30/2023

**Questions No. 11:** What is the name of the Dental sub-contractors (dental van contract) that provide services for Grant County Detention Center?

**Question No. 20:** Grant County has developed with the current contractor a Medically Assisted Treatment program. Is it the County's desire to continue the MAT program? If so, is there dedicated staffing and other costs associated with the MAT program not specifically identified in the RFP?

**Response No. 20:** Yes, Grant County will continue to provide MAT to its detainees. The cost varies depending on the amount of medication dispensed and how many participants are enrolled in the program. Current staffing includes a MD, a Health Services Administrator, and a LMSW.
