RFP AMENDMENT NO. 1 & QUESTIONS & ANSWERS NO. 1 JUNE 13, 2018

1. Does the District already have an Educational Specification (Ed Spec) to be used for this project? If not, will this need to be procured and completed prior to proceeding with full design, since PSFA typically requires that an Ed Spec be in place prior to architectural design?

ANSWER: Yes, the district has an Educational Specification for this project.

2. Is Landscape Architecture (planting and irrigation design) to be included in our proposal?

ANSWER: Yes.

3. Is I.T./Fire/Security design to be included, or will the design be completed by a third party hired by the District?

ANSWER: Yes, these items are included in the scope of work. Please refer to RFP Section IV. A. DETAILED SCOPE OF WORK.

4. Can you share who is on the selection committee?

ANSWER: No. The evaluation process is confidential until after award.

5. Wasn't Peralta ES included in the last project / RFP of yours? What happened with that?

ANSWER: The most recent RFP for design professionals was inclusive of several projects throughout the district including the re-roofing of three buildings at the Peralta Elementary School.

6. Will the RFP be amended to indicate that it is for early assistance with project scope and funding, rather than full design? Or will this selection result in a contract for both early assistance and full design?

ANSWER: This RFP is for full design only, there will be no early design assistant required.

7. Will the architect selected for this phase be given the option to continue on to full design, or will a separate RFP be issued to select the architect for design services?

ANSWER: See answer to number 6.

8. Will the architect that is selected for this phase be precluded from providing full design services, since PSFA typically does not allow firms involved in early planning efforts to be selected for design?

ANSWER: See answer to number 6.

9. If all the funds needed to build the entire school (for 500) are not immediately available, is there the possibility that the construction work will be phased?

ANSWER: The building size related to occupancy has not yet been determined. Although 500 is a typical number used for elementary schools the Public School Facilities Authority (PSFA) will make that determination if and when Los Lunas Schools is awarded the funding.

10. Has the District considered making the improvements to the temporary campus (DFES/Old Century High) a separate project?

ANSWER: No. If it is determined that a temporary campus is needed, it will be included in the same project.

11. Is this project contingent upon funding from the PSFA?

ANSWER: Yes. The District is now in the process of requesting funding for this project from PSFA. We anticipate that the funding awards will be announced in September 2018. If the LLS District is successfully awarded the funding, the project will begin immediately and require the services of the awarded Design Professional from RFP 2019-001-MR. Please also refer to Amendment of Section I. A. Purpose of this Request for Proposal, Paragraph 2, which has been amended as seen in number 8 below.
