## Addendum 01 May 11, 2023 IFB 23-B0048 Myrtle Beach World War II Memorial

The purpose of this Addendum 01 to IFB 23-B0048 for Myrtle Beach World War II Memorial, dated May 11, 2023, is to list the key points of discussion from the mandatory pre-bid meeting and provide the sign-in sheet.

- The substantial completion date for this project is October 15, 2023.
- Liquidated damages are \$1,500.00 per day.
- The prime Contractor is responsible for thirty percent (30%) of the work.
- The Contractor is responsible for having the planned benches engraved and sandblasted.
- The City will provide a meter for water, however the Contractor is responsible for trenching to the work site.
- A transformer at the corner of Farrow Parkway and Kings Highway will be utilized for electricity for the finished monument. The Contractor is responsible for acquiring conduit from Santee Cooper.
- There are no work restrictions; the Contractor may conduct work at any time or day.
- The Contractor will install the sculpture upon its completion and delivery.
- The sculpture is being produced by a separate entity and will not be provided by the Contractor. The Contractor will only construct the foundation for the sculpture and will install/assemble the sculpture, at the instruction of the sculptor, upon delivery.
- The pre-bid sign-in sheet and Small Business Survey are attached and are hereby made a part of this addendum.
