ELECTRONIC MEDICAL RECORDS INFORMATION

Wellpath	Current provider utilizing electronic medical record. Includes proposal to move from current EMR system, to ERMA. 24/7 IT support available from Wellpath.
Southern Health Partners	Response from SHP: The licensure of the EMR program, set up and basic computer hardware would be approximately \$18,000. The County would own this system, as well as the purchased equipment. The additional costs beyond the initial set up are the JMS interface (we would have to get a quote from the County's JMS as to this configuration, we have seen some companies charge as much as \$5000 for the "bridge" from JMS to EMR, as well as any additional maintenance charges by them for this bridge), wi-fi connectivity, and monthly maintenance (from the EMR provider, we estimate this cost to be no more than \$350/month). Other costs could occur with server based vs cloud based storage.
Southern Correctional Medicine	SCM will cover the cost to integrate CorEMR for electronic medical records. SCM will cover the set up cost and monthly user fee. The County will be responsible for housing the records on their in-house server. *Infrastructure currently not in place.
