We are adding a slightly different price sheet with this addendum. The quantities for the adjustments have been removed and you are to price them as an each, with no extension into the total.

Q2. How many adjustments will be needed?

A2. Your site visit will give you the most information. There may be adjustments need that are not readily visible and that is why we reverted to just having an 'each' priced.
