1. Is there a specific location for the Sign(s) to go or will they go in the same locations as the existing Sign?

They will be placed in the same location as the existing signs for the **three** that will be hanging on the building. The two roadside signs already have monument structures that we would like them attached to.

There are two wall mounted signs (Fort Mill Elementary and Sugar Creek) and two that are double sided (Fort Mill Middle and Springfield Middle).
