SUBMIT OFFER BY (OPENING DATE) AND TIME REMAINS THE SAME.

Q1: I see where your RFQ will be for a year 4/17/23-/4/16/24, do we need to hold the pricing for the year or 90 days?

A1: No change. Yes, pricing will need to be held for one year from date of award notice.

Q2: When will you want these boards delivered?

A2: No change. On an as needed basis for one year.

Q3: Are you accepting alternates?

A3: No change. No.

Q4: Are you wanting installation and white glove services?

A4: No change. No.

Q5: How many copies do you want of this submission?

A5: No change. See page 3. One.

Q6: Is this awarded line by line or all or nothing?

A6: No change. See page 12 of the solicitation clause "AWARD CRITERIA - BIDS: and AWARD TO ONE OFFEROR:"

Q7: Please confirm all markerboards/tackboards will be delivered to one central storage location. (i.e. 1160 Highway 501 East; Conway, SC 29526)

A7: No change. Yes.

Q8: Please confirm installation is NOT required as part of this solicitation.

A8: No Change. See answer 4 above.

Q9: Do you have a required timeframe for delivery?

A9: No Change. See answer 2 above.

Q10: Due to the size of this solicitation, is Horry County Schools willing to pay a deposit prior to order entry?

A10: No change. See page 13-14 in the solicitation clause "PAYMENT & INTEREST (FEB 2015)"

Q11: Are the quantities provided below, by item, the minimum that you will purchase at a time?

A11: No change. No, this is the estimated quantity of boards used in one year.

Q12: When are you expecting to want install on the whiteboards and tackboards?

A12: No change. The District will handle installation of all boards.
