FAILURE TO DO SO MAY, AT THE OWNER'S DISCRETION, SUBJECT THE BIDDER TO DISQUALIFICATION

1) QUESTION: There are currently (3) outdoor heat pump units connected to the existing AHU coil which will require recovery of refrigerant and disconnecting of line sets for each circuit to install the new coil. Does the County want to maintain possession of the existing refrigerant (R-22) charges for each circuit and if so will they providing recovery cylinders to store the refrigerant in?

ANSWER: The County does not want possession of refrigerant

2) QUESTION: The new dual circuit heat pump will require controls/thermostat to provided 2 stages of cooling/heating (based on space/return air temp in mechanical room where AHU is located). Will the County be providing the controls/thermostat and connecting it to the new heat pump or does that need to be included in the scope of the project by the Contractor?

ANSWER: County will provide

 ANSWER: yes
- 4) <u>QUESTION:</u> Can a Business License be acquired by the Contractor after the project has been awarded but prior to commencement of any work? <u>ANSWER:</u> No, bidders should already have a current business license.
- 5) QUESTION: What is the anticipated date of award for this project (this will determine if the job can be completed by 6/30/20 deadline due to current equipment lead times)?

 ANSWER: This project will be awarded as soon as possible, should be no later than May 20th, should approval by the Board of Commissioners be needed (meeting May 19th). This will be determined by the cost of the project.
- 6) <u>QUESTION:</u> One says coil replacement and the other says 15 ton two stage heat pump. Can you provide details from these units. What type of unit is the first unit for the coil? Would you guys like to keep the same brand?
