- Dr. Benjamin E. Mays Elementary, the teacher pulled chair out from under the student. Staff Removed.
- o GL 5/13/22 \$40K open child fell and broke arm any other details location? Hodges Elementary, chain on swing broke and child fell. Swing was removed.
- o GL 3/10/20 \$55K closed student carried off bus any other details? Any changes made as a result? **Student carried off the bus by arms and legs, filed a humiliation claim. Updated training for staff.**
- o GL/A&M 2/13/20 \$505K abuse of students need more specific details of the incident how many students? What location? Any changes made as a result? Was this
- a GL claim or abuse/molestation claim? It was a liability claim, Northside Middle School, physical abuse from staff to students, 4 students. Staff was terminated and charged.
- o SBLL 6/9/23 \$30K open wrongful termination provide more details of claim. **Employee alleging wrongful termination after she was injured on job.**
 - 4) Do any locations have rooftop HVAC systems? If so, which have some type of hail guards? We do have some rooftop and according to maintenance about 85% have hail guards. The new units come with them.
 - Can you provide a current drivers list with name, date of birth, state of license and driver's license number? Please see attached Driver's list. We cannot give out the date of birth or license numbers, they must be requested from DMV.
 - 2) Can we schedule a 20-30 minute virtual call for one of our workers compensation insurers with your workers compensation coordinator? They require a loss control call before quoting. No. but we can provide answers in writing that will be distributed to all vendors, if received before the new extended question deadline on March 22nd at 4:30PM. As stated in the bid

packet on Page 2, #2. " All amendments to and interpretations of the solicitation shall be in writing. Should an Offeror find discrepancies or ambiguities in or omissions from the proposal documents, or should he be in doubt as to their meaning, he shall at once, and in any event not later that seven (7) days prior to the proposal due date, notify Greenwood School District 50 who will send written addenda to all Offerors. Should an Offeror desire any explanation regarding the meaning or interpretation of the proposal documents, request should be made in writing at least seven (7) days before the date established for submission of proposals. Any change interpretation made will be in the form of written addendum to specifications and will be furnished to all Offerors, and its receipt by the Offeror shall be acknowledged on the proposal schedule. It shall be the Offerors responsibility to make inquiry as to the addenda issued. All addenda shall become a part of the proposal document, and all Offerors shall be bound by such addenda whether or not received by the Offeror."
