This addendum is being published to respond to a question asked by a potential bidder and to add additional clarification regarding the above-referenced Invitation to Bid. This addendum becomes a part of the Contract Document and modifies the original specifications as noted.

Question 1: If a bidder is not able to simultaneously bond both City of Knoxville Projects that open bids on the same day but wants to bid on both projects, what should they do?

Response: Bidders who are not able to effectively bond both City of Knoxville Projects simultaneously may still submit a bid bond for both projects. However, such bidders are required to state, in their bid submission(s), that they are not able to complete both projects simultaneously. The City will then consider their bid(s) for both projects, but will only award a contract for one of the projects if, in fact, said bidder submits the lowest cost most responsible bid for both of the projects. Additionally, the decision as to which project the City will award a contract for is at the sole discretion of the City and will be done in a manner that is the most advantageous to the City.

Additional Clarification:

1. The City of Knoxville is in the process of updating our standards for tactile warning systems in curb cuts to switch from black to yellow tactile warning systems. Please note that any new tactile warning systems installed in this and future City of Knoxville projects shall be yellow in color.
2. Utility relocations noted in the plans on sheets 15 and 16 will be performed by KUB in advance of the Notice to Proceed to Construction for this sidewalk project.
3. A handrail has been added to the top of the proposed retaining walls. Details for this railing are included on the revised plan sheets. The cost of the railing shall be included in Pay Item 81.10 Redi-rock retaining wall.

4. A drain inlet has been added to capture offsite drainage in front of Weigels. Reference the revised Proposed Layout Sheet 16A for more information. The revised bid form also reflects this change. All material, equipment, and labor necessary to perform this work shall be paid for under Pay Item 20.40 Adjustment of Drainage Structure (Weigels).
