Question: Is there a budget for the captioned project?

Response: Engineer's Estimate (with 10% contingency) is four hundred seventy thousand seventy-one dollars with eighty cents (\$470,071.80).

Question: Does the bidder have to bid on (ALL) bid items or can we bid on the items we select?

Response: Prospective Bidder must bid on all items (a complete bid). The Bidder may want to team up (be a sub-contractor) to another General Contractor if they do not want to pursue all items.

Question: Are there any Union Labor requirements to this contract?

Response: There are no Union Labor requirements.

Question: Could you please share with us information about the mentioned projects?

Response: We will need to review and approve any TTCP/MOT Plans presented. In theory, we could allow off-peak hour closure during working hours. The road will need to be open during non-working hours.

Question: Is the Florida State Underground Utility and Excavation License and Miami-Dade Construction Trades Qualifying Board Paving Engineering License sufficient qualifications for this project?

Response: Yes, these specified licenses would qualify for scope of work on this project.

Question: How many days will the Bidder have to complete the project?

Response: The Bidder will have one hundred eighty days (180).
