4. SPECIAL CONTRACTOR/SUBCONTRACTOR QUALIFICATIONS

The Contractor shall have three (3) years of experience conducting public works infrastructure, streetscape, and bioretention projects. The experience shall be work of similar size and scope, construction, re-construction, and maintenance.

The Contractor obtained project experience shall consist of the following:

- State and County streets, asphalt paving full depth, milling and overlay
- Curb, gutter, concrete sidewalk, driveways and walkways
- Storm sewer infrastructure, pipes and inlets
- Wet utilities including Watermain and appurtenances
- Gravity Retaining Walls
- Electrical conduits
- Streetscapes and related site
- Bioretention with associated items, infrastructure, soil, and vegetative components

The following clarifications are made as a result of vendor inquiries:

This bid does not indicate on-call services and it contradicts the bid as a lump sum project. Can you clarify if this requirement is needed in addition to the qualification requirements listed on pages 8-9? Answer: No, the requirement of three continuous years of on-call services are not needed in addition to the qualification requirements listed on pages 8-9.
