RE: Addendum No. 1, dated November 21, 2017

This Addendum forms a part of the Contract Documents and modifies the original Bidding Documents dated October 27, 2017.

This Addendum consists of two (2) pages, one (1) Bid Tabulation page, and one (1) Patch Measurements page.

Add. 1.1	Modification: The Bid Tabulation has been modified to add a 'VALVE BOX ADJUSTMENT' bid item for two water valves located on High Falls Road. The Contractor should submit the revised Bid Tabulation with the RFP.
Add. 1.2	Modification: The patch measurements for each road, as marked by Spalding County personnel, are attached to this addendum for the Contractor's use.
Add. 1.3	Clarification: The overlay area on High Falls Road ends just past First Street at the Griffin city limits. The sanitary sewer manhole and storm drain inlets west of First Street will not be affected by the overlay project.
Add. 1.4	Clarification: Asphalt overlay on Teamon Road will end at the railroad right-of-way, approximately 50 feet from the railroad centerline on both sides.
Add. 1.5	Clarification: All work shall be performed Monday – Friday between the hours of 7:00AM and dusk. Work may be performed on Saturday with prior written permission from Spalding County.
Add. 1.6	Clarification: High Build paint is not required for striping. The Contractor should follow the previous GDOT specification.
Add. 1.7	Clarification: The Contractor shall install temporary pavement markings and allow the new asphalt surface to cure $30 - 45$ days before installing permanent pavement markings. This cost for temporary markings may be included in the 150-1000 TRAFFIC CONTROL line item.

Add. 1.8	Clarification: The time allowed for completion of the project is 105 Calendar Days after the Notice to Proceed is issued.
Add. 1.9	Clarification: Portable advanced warning signs on spring-loaded stands are acceptable for this project.
Add. 1.10	Clarification: The Contractor may 'run the gate out' for driveways and side roads while paving the mainline. A separate operation is not required.
Add. 1.11	Clarification: The quantity for leveling is intended to be for spot leveling as needed in the patch areas.
