## II. RFI QUESTIONS:

 The plan shows gutters on the front right corner of the bunkhouse. There is currently no gutter in this location, can you please verify if gutter will be going in that location and if so who will be removing the antenna that is in that corner?
 PROVIDE GUTTERS AND DOWNSPOUTS ACCORDING TO PLAN. COUNTY WILL REMOVE ANTENNA.

- The existing gutters and downspouts have currently been painted red. Will the new gutters and downspouts need to be painted red?
  DOWNSPOUTS AND GUTTERS WILL BE PAINTED BY COUNTY.
- There are PVC pipe vents in two of the valleys, these will have to be relocated. Should I figure these into the bid?
  RELOCATE VENTS OUT OF VALLEY.
- 4. There is some roofing that has shingles on it that is excluded on the plans. Is that correct? ALL SHINGLES SHALL BE REMOVED. "BIDDER IS RESPONSIBLE TO FIELD VERIFY ALL MEASUREMENTS FOR BIDDING AND INSTALLATION PURPOSES."
- 5. Has Gulf Coast Supply and Manufacturing been approved as an alternative vendor for the metal? **REFERENCE THE DRAWINGS, SHEET SP-1, DIVISION 7, SECTION 07610.**
