

**RESOLUTION NO. 2020-041**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, TO AWARD THE LOWEST, RESPONSIVE AND RESPONSIBLE BIDDER, FLORIDA PALM CONSTRUCTION, INC., FOR THE CITY HALL MULTI-PURPOSE ROOM REMODEL, ITB 2020-07, IN THE AMOUNT OF \$123,323; PROVIDING FOR EXECUTION; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Parkland (City) requires the services of a qualified contractor for City Hall Multi-Purpose Room Remodel; and

**WHEREAS**, on April 29, 2020, in accordance with the City's Procurement Code, City staff issued Invitation to Bid (ITB) No. 2020-07 for City Hall Multi-Purpose Room Remodel; and

**WHEREAS**, on June 9, 2020, the City opened the ITB and fifteen (15) bids were received; and

**WHEREAS**, City staff have reviewed the low bid and after careful evaluation is recommending the award to the lowest, responsive and responsible bidder, Florida Palm Construction, Inc., in the amount of \$123,323; and

**WHEREAS**, funds for the City Hall Multi-Purpose Room Remodel have been budgeted for the 2020 fiscal year; and

**WHEREAS**, the City Commission hereby determines it to be in the best interest of the residents of the City of Parkland to award Florida Palm Construction, Inc., in the amount of \$123,323.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:**

**Section 1.** The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporated herein.



**Section 4.** The ITB packet has been reviewed and approved by the City Attorney.

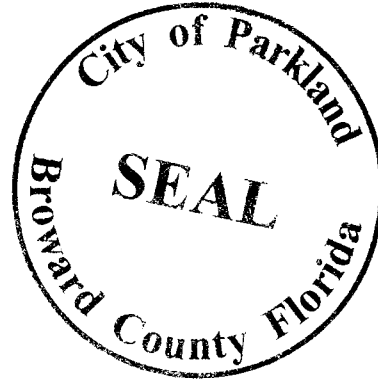
